

# GOODS OF IMPORT CONSIGNMENT COULD NOT BE CONSIDERED AS COMPARABLE GOODS FOR ENHANCEMENT OF VALUE UNDER RULE 3 OF RULES 1963 - SC

# Commissioner Of Customs (Import) Versus Reliance Industries Ltd.

Hon'ble Supreme Court in the case of *Commissioner Of Customs (Import) Versus Reliance Industries Ltd.*<sup>1</sup> upheld the decision Ld. CESTAT, Mumbai noted that goods of import consignment could not be considered as comparable goods for enhancement of value of such consignment under Rule 3 of Customs Valuation Rules, 1963 as said Rule did not intend comparable goods to include supplies to importer, stating that this order could not have interfered. The respondents had the unsupported assumption of price in the proforma invoice to be that of the four assembled spinning machines in the consignment and described them as 'comparable goods' produced by the same manufacturer without pausing to consider the format of Rule 3 of Customs Valuation Rules, 1963.
